From another E-mail came this appeal:

- 3. The government should take strong action against police officials and military personnel who reportedly witnessed a number of incidents but failed to take any action to protect women victims of violence

RE: VIOLENCE AGAINST IN-DONESIAN WOMEN OF CHI-NESE DESCENT

Dear President Habibie:

We, the undersigned express our deep anguish and grave concern over the recent reports of alleged violence and rape committed against over 200 Indonesian women of Chinese descent. We urge you to take immediate steps to ensure that proper medical care is provided to women victims and an immediate investigation is launched for these cases by the Human Rights Commission of Indonesia.

We draw your attention to the international news reports between 12 May to 21 May 1998 which record that during the riots in Jakarta, Medan and in the Chinese commercial district of Glodok, girls and women between the ages of 10 to 55 were forced to take off their clothes and dance in the streets, raped and, in some cases, raped and burnt to death at various locations such as private homes, banks, public buses, streets and shops. In many cases, violence was committed in the presence members family of neighbours.

It was also reported that these women were targeted because of their ethnicity and religion as some of them were told that they deserve this treatment because they are "Chinese and non-Muslims." Newspaper reports have noted that apart from targeting Chinese owned homes and shops, at various occasions during the riots, groups of Indonesian men stopped city buses, entered banks or shops, forced all "non-Chinese Indonesian women" out and then raped the ethnic Chinese women.

We respectfully urge you to immediately act to take all necessary measures to ensure that the persons responsible for committing these violent crimes against Indonesian citizens of Chinese descent are held accountable.

We also urge you to take strong action against Indonesian police officials and army personnel who reportedly witnessed a number of incidents but failed to take any action to protect these women victims of violence.
