

#### Asian Women in the Information Age: New Communication Technology, Democracy and Women

ach successive wave of New Communication Technologies (NCTs) has arrived claiming to herald a new democratic age, promising greater awareness and political participation for all elements of society. However, where gender equality is concerned, the influence of NCTs has often been less than neutral. This book examines the implications of NCTs on democracy for women in Asia; it covers the extent to which women are utilising them and highlights the cultural, social, and political barriers women face in incorporating them into their lives. It also addresses

some of the negative aspects of these technologies, such as the stereotypical portrayal of women by the mass media, and prejudices regarding women's facility with technology.

The countries of Asia differ markedly both in technological development and social norms. Asian Women in the Information Age is the product of a research project conducted in China, India, Indonesia, Malaysia and Singapore, with articles covering six additional countries. This important study addresses the variety of cultural realities in the region and offers several perspectives on the effects of NCTs.

ot since The Female Eunuch has there been a book so radical in its scope, so persuasive in its detail, so

exhilarating in its polemical energy. Beginning with Ada Lovelace and her unheralded contributions to Charles Babbage and his development of the Difference Engine, Sadie Plant traces the critical contributions women have made to the progress of computing. Shattering the myth that women are victims of technological change, Zeroes + Ones shows how women and women's work in particular-weaving and typing, computing and telecommunicating have been tending the machinery of the digital age for generations, the very technologies that are now revolutionising the Western world.

# Women, Public Policy and the State

his book is a timely analysis of the impact of the restructuring state on women's policy agendas. During the 1980s, femocrats in public bureaucracies and in feminist community and advocacy groups played a significant role in shaping policies and programmes to take account of women's interests.

As we move into the 21st century, managerialist and market reforms under neoliberal forms of corporate governance have undermined previous gains in policy, programmes and public involvement—in areas such as childcare, family policy, child support, equal opportunity, justice, health and industrial relations. Expert contributors from Australia and elsewhere explore the impact on women's interests of the restructuring state, the shrinkage of women's policy machinery and the discursive framing of policy agendas.

The important book examines transformation in the feminist agenda of the 1980s and 1990s and explores just what women's policy and policy structures in 2000 and beyond might look like. It will appeal to students across a range of disciplines, policy makers, advisers and workers in government and nongovernment organisations. and all women seeking to understand the policy changes they are witnessing.

ontrol of women's sexuality remains one of the most powerful tools



onventional approaches to women's empowerment are based on the twin assumptions that alleviation of poverty will automatically lead to their empowerment and that the major constraint on programmes for upliftment is monetary. The result of five




decades of planning, however, has shown that economic assistance by itself does not necessarily improve the status of women. The author argues that the more vital inhibiting factors leading to the disadvantaged position of women are their ignorance, powerlessness and vulnerability. This immensely insightful book emphasises the need for bringing about an attitudinal

change among women as the most important step towards empowerment.

The author focuses specifically on rural Scheduled Caste and Scheduled Tribe women, who, she says. are triply disadvantaged as women, as members of the rural section of the populace and as members of a lowly caste. The book compares the effectiveness of state initiatives with the motivation-andconscientisation strategy advocated by AWARE (Action for Welfare and Awakening in Rural Environment), a nongovernmental development organisation working in 6,000 villages spread over seven states in India. It analyses the success of AWARE's work amongst women through various case studies and concludes that, besides monetary resources, it is the mindset of the policy makers, bureaucrats and particularly the women concerned that must change in order to assist the empowerment of women.

# Assembling Gender: The Making of the Malay Female Labour By Alison Wee Siu Hui



It shows how the state and the business corporations imposed various methods of labour control with the view to marginalising the rights of women workers. However, despite the lack of organised struggle, the women workers have shown that they are not docile or passive as commonly perceived. On the contrary, they practised a subtle form of collective resistance that is often unrecognised as such. Assembling Gender clearly illustrates how the modern processes of globalisation and industrialisation have enormous impacts on women's daily lives.

#### Disposable Domestics: Immigrant Women Workers in the Global Economy

Illegal. Unamerican. Disposable. In a nation with an unprecedented history of immigration, the prevailing image of those who cross the U.S. border in search of equal opportunity—in particular women of colour of childbearing age—is that of a drain on society. Grace Chang's vital account of immigrant women's experi-



ences proves just the opposite: that the women who perform the least desirable jobs in the U.S.—as nannies, domestic workers, janitors, nursing aides, and homecare workers—are the most crucial to the American economy and society. Yet, Chang also shows, they are among the most vulnerable and exploited, many being undocumented and therefore disenfranchised.

Chang dismantles recent arguments in favour of curbing immigration and eliminating access to education, health care, and welfare, piercing the rhetoric to reveal the racism and misogyny underneath. She unravels the twisted history of U.S. immigration policy and its role in drawing much-needed workers to the "land of opportunity" and then discarding them when the need has passed. Most importantly, she highlights the unrewarded work that immigrant women perform as caregivers, cleaners, and servers and shows how these women are actively resisting the exploitation they face.


# What Women Do in Wartime: Gender and Conflict in Africa

hat Women Do in Wartime is the first book to describe and ana lyse the experience of women in African civil wars. A mixture of reportage, testimony and scholarship, it includes contributions from women in Chad, Liberia, Mozambique, Namibia, Rwanda, South Africa and Sudan. The political context of these conflicts is outlined in an introduction to each chapter. The book profiles women's responses to war, as combatants as well as victims, and describes the groups women organise in the aftermath.

What Women Do in Wartime offers startling new testimony that will provoke sharp controversy. The writers speak of rape, the broader issues of sexual torture and sexual slavery and the way war and political repression distort women's lives. The South African chapters bare the torment of women in the ongoing conflict in KwaZulu/Natal and present the case for a gendered approach to women's testimony before the Truth and Reconciliation

Commission. The contribution from Mozambique describes pathbreaking work on the effect of civil war on a nation's psyche and on individual behaviour. The chapter on Sudan evokes the suffering of southern women, as warriors, kidnap victims, sexual slaves and



refugees, while a Rwandan woman describes the complex sexual pressures on women in a civil war that has been obscured by simplistic tribal explanations. Two reports detail the experiences of Chadian women in the civil war that started in 1965 and the brutality against women in the recent civil war in Liberia. A Namibian woman recalls her eight years as a guerilla fighter for SWAPO, while the final chapter analyses the militarisation of Africa and places the conflicts in the framework of international relations.

The first book to examine rape and other forms of gendered political violence in African civil wars, this extraordinary volume is also about women taking action for change. It is set to become required reading for students and academics in the fields of women's studies, peace studies and African studies.

### Take a Step to Stamp Out Torture

hree-quarters of the world's governments have used torture in the past three years. In police stations and prison cells, on city streets and in remote villages, torturers continue to devastate the lives of countless victims. For some the result is an agonising death. For survivors life can never be the same again. Some scars heal. Others continue to disfigure the mind and the body long after the torture has ended.

This report draws on recent reports of torture



and ill-treatment from more than 150 countries. The victims are criminal suspects as well as political prisoners, the disadvantaged as well as the dissident, people targeted because of their identity as well as their beliefs. They are women as well as men, children as well as adults.

Action to eradicate torture is needed urgently, and this report launches a worldwide Amnesty International campaign against torture. Drawing on decades of experience in researching and working against torture, Take a Step to Stamp out Torture focuses on three major areas—preventing torture, confronting discrimination and overcoming impunity.

This report bears witness not only to the cruelty of the torturers, but also to the courage and determination of torture survivors and human-rights defenders. It shows that there is no shortage of information on how to stop torture, only a lack of political will. It aims to galvanise people around the world in a collective effort to eradicate torture from the face of the earth.

#### Hidden Scandal, Secret Shame: Torture and III-treatment of Children

Tt is hard to believe that Lanvone would deliberately torture a child. Yet around the world, girls and boys are being subjected to horrific violence and abuse. Children are tortured because they are caught up in wars and political conflict. Children in custody are vulnerable to ill-treatment by police and security forces, and are often detained in conditions that pose a threat to their health and safety. Many face being beaten or sexually abused by the very adults who are supposed to

protect them. The effects of torture on the future life of the child should not be underestimated. They may be felt for generations to come.

Hidden Scandal, Secret Shame draws on many reports of torture of children documented by Amnesty International and other human-rights organisations. The victims are children from all regions of the world. Some are the accidental victims of the carnage of war; some have been deliberately targeted by armed forces; some have themselves been forced to take up arms, and to carry out acts of torture. Children are tortured for political activism or alleged criminality, or simply because they are socially marginal; they are targeted because of their identity as well as their beliefs. Dozens of harrowing cases are presented in this report, yet they are no more than the tip of a very large iceberg. The torture of children is a widespread, worldwide scandal, and concerted public action must be brought to bear on governments to force them to live up to their legal and moral obligation to protect children

Amnesty International has drawn on decades of

experience in research and working against torture to launch its global campaign against the use of torture. This report is released as part of that campaign and aims to mobilise people around the world to take action to stop the torture and ill-treatment of children.

# Mainstreaming Men into Gender and Development: Debates, Reflections, and Experiences

urrently there is much public debate about "men in crisis," "troubled masculinities," and "men at risk." Although women continue to bear a disproportionate share of material, social, and civil disadvantage, there is a growing awareness that men in some contexts also face marginalisation because of their gender roles and identities.

This working paper, based on research commissioned by the World Bank, argues for a mature understanding of how gender, race, and poverty interlink to disadvantage particular categories of men, as well as women. Men, and male gender concerns, must be incorporated in gender and development interventions at the grassroots level, so that issues facing both sexes can be considered together. Current "in-house" approaches in more than 30 development organisations are reviewed, and suggestions are made for a more gender-balanced, men-inclusive approach.

#### Prime-Time Feminism: Television, Media Culture, and the Women's Movement Since 1970

Tn Prime-Time Feminism, L Bonnie J. Dow examines feminist representations in popular entertainment television and argues that television has been a key participant in the cultural dialogue about feminism in the United States. Approaching television as a fan, as a critic, and as a feminist, Dow focuses on how the medium adapts to, structures, and attempts to frame cultural understandings of social change over time.

Although Dow discusses a wide variety of television programming, she provides specific case studies of The Mary Tyler Moore Show, One Day at a Time, Designing Women, Murphy Brown, and Dr. Quinn, Medicine Woman. She juxtaposes analyses of genre, plot, character development, and narrative struc-

ture with the larger debates over feminism that took place at the time the programming originally aired. Dow emphasises the power of the relationships among television entertainment, news media, women's magazines, publicity, and celebrity biographies and interviews in creating a framework through which television viewers "make sense" of both the medium's portrayal of feminism and the nature of feminism itself.

Prime-Time Feminism highlights the continuing tension between the commodification of select, simplified feminist images and the complexities of feminist politics.

#### No Longer a Secret: The Church and Violence Against Women

violence against women happens in every country, age group and sector of society, in the home, at the workplace. Apart from the infliction of physical harm, sexual harassment, rape and sex tourism, it takes subtler form in the psychological and emotional demeaning of women. Its extent is seldom acknowledged: its victims are often afraid or embarrassed to speak out-or silenced and discredited if they do. Churches too have turned a blind eye to its presence in their own institutional life, sometimes even condoning it. Few are ready to ask how their own structures may perpetuate abuse of power and keep women insecure and fearful.

But there are also signs of hope, and this book points to some of the ways in which women and men in the church and elsewhere are beginning to struggle courageously against all forms of violence against women.

This revised edition includes an additional chapter detailing responses to the issue of violence against women by the World Council of Churches, especially in the context of the Ecumenical Decade of Churches in Solidarity with Women. In addition, the extensive list of resources available from churches and church-related groups has been updated.



#### No Hiding Place: Child Sex Tourism and the Role of Extraterritorial Legislation

hild sexual abuse is at-concern and attention in many parts of the world. In recent years, it has taken on a novel form involving abusers masquerading as tourists and travelling to countries where children may be particularly vulnerable. Men from Europe, the U.S. and Japan now visit Third World and Eastern European countries in order to engage in the sexual abuse of young children. This book examines a new departure in international cooperation to suppress this prac-



tice whereby a number of countries—including the U.S., many European nations, Japan and Thailandhave passed legislation making possible the arrest and trial of their citizens for these offences even when carried out beyond their borders.

This book records the speed and efficiency with which this initiative has been brought about. It presents a number of case studies from a variety of countries that have been collected by the Dutch Section of Defence of Children International. It makes clear the important role being played by NGOs, notably ECPAT International (End Child Prostitution, Pornography and Trafficking in Children) which now comprises over 40 organisations worldwide. It provides examples of successful prosecutions that have been brought and the obstacles that still stand in the way of using this legal instrument to suppress child abuse. In particular, it shows how great is still the need to develop guidelines, codes of practice and new procedures in cooperation in order to help law enforcement authorities prosecute these cases where more than one national jurisdiction is involved.


Those involved in child protection, from teachers to social workers and police, will find the material in this book an insightful resource in alerting them to the problem and new ways of confronting it.



Women and Leadership is about leadership in many contexts: women resisting exploitation in the workplace; women heading households; women leading in the international policy



#### Women in Asia: Restoring Women to History

omen in Asia is one of four volumes in the Restoring Women to History series. The original teaching packets on which the series is based, published in 1988 by the Organization of American Historians, played a key role in the revision of the history curriculum and the incorporation of women into the study of world history. The explosion of scholarship on women over the past decade has prompted a major reexamination and expansion of the original materials into four separate volumes. Dealing with women in Africa, Asia, Latin America and the Caribbean, and the Middle East, these volumes consider what questions are in cur-



rency at this stage in the field of women's history, what type of evidence is available, and what gaps exist within the scholarship. Each volume features an introduction by an expert in the history of the area. The general introduction by Chervl Johnson-Odim and Margaret Strobel sets out the general themes and issues that emerge from the series and addresses points of comparison and difference between the regions. The aim of Restoring Women to History is to demonstrate the value of comparative history while generating new questions and shedding new light on current scholarship in the non-Western world.


In this volume, the author writes on South and Southeast Asia, surveying both the prescriptive roles and the lived experiences of women, as well as the construction of gender from early states to the 1990s. Although both regions are home to Hindu, Buddhist, and Muslim religious traditions and had extended trade relations, they reveal striking differences in the status and roles of women and the processes of cultural adaptations. Sievers presents an overview of women's participation in the histories of China, Japan and Korea from prehistory to the modern period that provides a framework for incorporating women into world history classrooms. It offers analyses on major issues derived from recent research and discusses such stereotypical cultural practices as footbinding (long seen as "exotic" in the West) in the context of women's lives.

#### The Mountain is Moving: Japanese Women's Lives

The Mountain is Moving describes postwar Japanese society and the roles that women are expected to play within it. Based on hundreds of interviews, the book examines many spheres of



women's lives, including education, marriage and child rearing, work outside the house, caring for the elderly, political power or lack of it, and volunteerism. Patricia Morley also examines a diverse and compelling range of stories and novels by and about Japanese women, revealing both the patterns that concern sociologists and the exceptions that interest philosophers and writers.

Morley asserts that the legendary Japanese system of

white-collar labour can only be maintained by the efforts of women who remain at home to take care of their husbands, their children, and their ageing relatives. In recent years, however, increasing numbers of Japanese women have begun to seek change and empowerment beyond the domestic sphere.

Engagingly written, The Mountain Is Moving is a unique introduction to Japanese society and will appeal not only to those curious about modern Japanese culture but also to all those with an interest in women's issues.



#### The Ink Dark Moon: Love Poems

ne thousand years ago the Heian court of imperial Japan was one of the most sophisticated cultures on earth. The literature of the classical age is the only one in which the predominant geniuses were women; foremost among them were the two masterfully translated in this volume. Ranging from the deeply erotic to the profoundly spiritual, the poems



of Ono no Komachi (ca. 850) and Izumi Shikibu (974?-1034?) served sometimes as intimate exchanges between lovers (among the Heian elite, verse was an indispensable part of courtship), other times to record the most private emotional and spiritual concerns of the accomplished and passionate women. Elegant, sensuous, insightful, and piercingly lovely, the poems in The Ink Dark Moon speak to us from the distant past with an immediacy that brings us to a deepened experience of the present.
