

R ural communities throughout India, particularly those in the mountains, depend on the forest for their sustenance and livelihood. However, the introduction of inappropriate development



programmes combined with the growing intrusion of a capitalist economy, has led to the rapid depletion of forest resources. Brenda Canney focuses on the ways in which the degradation of the environment has affected the lives of poor women in rural India.

The Mountain Women of Himachal Pradesh vividly demonstrates the ways in which the depletion of forests has eroded the biomass-based subsistence economy of the hill regions, leading to an increased workload for women. It has affected their health and their experience of family and culture. It has also heightened their poverty and educational deprivation.


Canney's research also reveals that in coping with the changes brought about by capitalist development projects, women have had to resist traditional patriarchal and cultural expectations. As a consequence, they are taking greater control over their lives.





process of he globalisation has had a dramatic impact on the lives of women in developing countries in the past decade. They have been increasingly drawn to an insecure, flexible employment for the world market. The feminisation of the labour market has increased the burdens of women. The inability of men to access full-time, well-remunerated employment has exacerbated the process of male out migration and has left many families headed by women. At the same time, the reduction in state services and welfare has increased the burdens placed on women. However, the consequences of globalisation have been different for different women in different places. For some, it has created opportunities for greater empowerment, whilst in others, it has stimulated a reaction and increased the subordination of women.

Halesh Afshar and Stephanie Barrientos document the experiences of women in diverse local contexts within different cultures and faiths, drawing on case studies from Asia, Africa and Latin America. 

# Gender Discrimination in the Kashmir Valley: A Survey of Budgam and Baramulla Districts

By Bashir Ahmad Dabla, Sandeep K. Nayak and Khurshid-UI-Islam

The phenomenon of "gender discrimination" exists more or less in all societies of the world regardless of differences in region, religion, economy, policies, education, culture, social structure, etc.



Sociological studies carried out at the global level and in cross-cultural context have revealed that women, in general, were not considered equal to men at the social level; they were not allowed to become active partners in the pro-

cesses of change and development. Like other societies/communities in the Indian subcontinent, the Kashmiri women face a certain set of gender-based discrimination in the traditional situation. However, as a result of cumulative effect of the processes of modernisation, this situation has changed qualitatively as well as quantitatively. While the direction of this change stands towards their total development and emancipation, it has also given rise to some crucial problems. It was in the context of preceding social dynamics that the study was carried out in the Kashmir valley.

Based on a revised version of the report of an extensive empirical study carried out in Baramulla and Budgam districts in 1996-1997 among 600 selected and representative respondents, and on the proceedings of the National Seminar in Srinagar in August 1997 organised jointly by the United Nations Children Fund (UNICEF), New Delhi; Jammu and Kashmir Government; and Department of Sociology, University of Kashmir, the book discusses the findings of the report and prepares a set of recommendations to negate and debase the practices related to gender discrimination in the valley.

omen constitute half of the country's population. Yet Sri Lankan women have never held more than six percent of the seats at any level of government/parliamentary, provincial or local.


Mario Gomez and Shymala Gomez contend that the number of women in government is unlikely to increase in the short term in the absence of a temporary quota or reservation.

According to the authors, no group defined with such precision can lay claim to such a monumental imbalance in representation. While women play a pivotal role in sustaining the family and society, they have few opportunities for influencing the laws and policies that shape their societies. A political reservation for women will ensure that women's voices are heard and their experiences are taken into account.

The authors propose several alternatives for amending Sri Lanka's electoral laws, including proposing a reservation for women in the national list.

ow do cultural notions of gender affect what kinds of technologies are produced and for what purpose? How does technology affect gender roles, either by reinforcing them or by destabilising them? What is the significance of sex and gender in the use of technologies such as cosmetic surgery and reproductive procedures that manipulate the body? Does "sexual difference" have any implications for the development of any technology? What does "gender" mean in a technologically influenced world?

Technology-from personal computers and cyberspace to artificial wombs and sex reassignment surgery-has opened up the possibility that sex roles as well as the gendered notions we have of human identity are subject to radical change. Leading scholars in science and technology studies, medical ethics, and gender studies, including Donna J. Haraway, Christine Overall, Sherry Turkle, and Autumn Stanley, assess the impact of technologies that are blurred distinctions between the sexes. An illuminating and often unsettling picture of ethical, moral, and legal issues that shape individual experience and culture in the late 20th century emerges from the interface of gender and technology.

#### Adolescent Sexuality in the Philippines Edited by Corazon M.

Adolescent research especially in the area of sexuality and its related behaviours has been scanty not only in the Philippines but also in many parts of the Asian region. This is not to diminish the importance of the subject but it has more to do with the sensitivity of the issue particularly in societies of the region.

The Philippines has the added characteristics of being a Catholic country and one, which has been undergoing massive changes in its socio-economic environment. These pose challenges to some dearly held customs and traditions. The on-going transition has been slow but significant, making adjustments for all concerned difficult and not without long-term consequences. This study aims to fill in important information gaps in under-tanding the knowledge, attitudes and behaviour of young Filipinos in a wide range of sex and sex-related issues together with some significant events and institutions affecting their behaviours.

The monograph is divided into ten chapters that presents analyses and discussions of some of the more important topics dealt with in Young Adult Fertility and Sexuality Study (YAFS-II). It includes, among others, a current profile as well as a short trend in selected social, economic, and cultural characteristics of the Filipino youth today.

Particularly interesting is the chapter dealing with three risk behaviors among adolescents—smoking, drinking and drug use.

about feminism and in doing so, opens up a number of hitherto closed debates, allowing for the possibility of moving those debates further.



hy is an alliance between ecology. peace, feminism, socialism and postcolonial movements so slow in coming? In this extraordinary polyphonic text, Ariel Salleh tells us why. Informed by a critical postmodern reading of the Marxist tradition, her ecofeminism integrates discourses on science, the body, culture, nature and political economy.

Salleh is known internationally for her gender



critiques of ecopolitics. Here she explores the philosophical challenge of ecofeminism, and shows how confusion over the implications of 'difference' has held back radical change. The book opens with an account of the so far invisible history of ecofeminist politics; the second part establishes ecofeminism's status as an embodied materialism; while part three argues that a way forward exists in the common agency of women's and indigenous struggles.

Salleh carries the terms of political argument to a new plane. Her analysis provides an antidote to neo-liberal complacency and is as essential for activists in an era of globalisation as it is for scholars of social theory, women's studies, environmental and postcolonial studies. C asting Pearls: The Women's Franchise Movement in Sri Lanka is an account of the first struggles of women for the right to vote. The 1920s was a time of political excitement and social change, a time when universal suffrage was being hotly debated and when Sir Ponnambalam Ramanathan said that giving women the vote was like casting pearls before swine.

The pioneering women of the Women's Franchise Union challenged all the diehards and came out boldly for the cause of basic democratic rights for women, namely, the right to vote, the right to contest elections and the right to sit in the legislature. Many spirited women of all ethnic groups led the movement. Among them were Lady Daisy Bandaranaike, Dr. Nalamma Satyavagiswara Aiyar, Florinda Wijeyekoon, Agnes de Silva, Dr. Mary

Rutnam,Nellie Gunasekera and Leelavati Aserappa.

The opposition they faced ranged from the frivolous to the absurd, and the women reformers were well able to handle their critics and make sharp rebuttals. But they also had the support of liberal and progressive men who believed that universal suffrage and gender equity were an essential part of democracy.



*ired Women* is a fascinating look at the lives of women online. The authors have put together






Patrice M. Buzzanell, who also provides frameworks and analyses that could be useful for additional critiques, examines feminist approaches to some organisational communication issues.



Things that women traditionally associate with the image of woman—the womb, the egg, the breast, the blood, the almighty clitoris—and things that women don't—movement, strength, aggression, and fury—are all here. Drawing on science, literature and history, Angier provides valuable insight into the power of hormones, breast milk and yes, the all-important clitoris.

ilipino Migrant Women in The Netherlands is a collection of life stories of four Filipino women which revolves around the formation of the women's selves, their consciousness of themselves as individuals, and the identities they choose to create (or are forced to take), continuously recreate, live, and negotiate on a daily basis.

Theirs are stories of individual women whose coloured and ethnic identities obviously differ from that of the mainstream white Dutch population, whose accents confirm these differences, and whose culture and values place them between the Dutch and the Filipino cultures, though never fully belonging to either.

Questions focus on the following: How do Filipino migrant women construct and negotiate their multiple identities in Dutch society? Specifically, how do they negotiate their gender, class, racial/ethnic and other identities in the context of Dutch society, also considering their experiences in the Philippines?


The objective of this research was to portray migrant women as people who are effectively functioning, actively participating, and fruitfully contributing to Dutch society, despite the stereotype images as problematic. This research also aims to contribute to the ongoing debates surrounding post-modern feminism, by grounding the concepts of multiple identities, agency difference and solidarity.

The Revolutionary Association of the Women of Afghanistan (RAWA) was established in Kabul, Afghanistan, in 1977, as an independent political/social organisation of Afghan women fighting for human rights and for social justice in Afghanistan.

The founders were a number of Afghan women intellectuals under the sagacious leadership of Meena, who was assassinated in Quetta, Pakistan, by Afghan agents of the then KGB, in connivance with fundamentalist band of Gulbuddin Hekmatyar, in 1987. RAWA's objective was to involve an increasing number of Afghan women in social and political activities aimed at acquiring women's human rights and contributing to the struggle for the establishment of a government based on democratic and secular values in Afghanistan.

Despite the suffocating political atmosphere, RAWA very soon became involved in widespread activities in different socio-political arenas including education, health and income generation as well as political agitation.
