

Feminism in Modern Japan: Citizenship, Embodiment and Sexuality By Vera Mackie

racing the history of feminism in Japan from the end of the nineteenth century to the present, Vera Mackie offers a fascinating account of those who rebelled against convention in the dissemination of ideas that challenged the dominant ways of thinking about women, men and society. Feminist activism took diverse forms as women questioned their roles as subjects of the Emperor, or explored the limits of citizenship under the more liberal postwar constitution.

The story is brought to life through extracts from the writings and surveys of activities of Japanese feminists from 1870s to the present. It involves a multi-lavered narrative that draws on the documents of the past, a dialogue with other historians, and an engagement with the ways in which feminist activists and historians have attempted to understand their own past, and the ways in which they have deployed their understandings of the past in addressing the issues of their own time.

This carefully documented analysis is for students of feminism and related areas where nothing comparable is currently available.

Feminism Without Borders: Decolonizing Theory, Practicing Solidarity by Chandra Talpade Mohanty

his volume collects the classic and new writings of Chandra Talpade Mohanty, feminist thinker and "vanguard of Third World and international feminist thought and activism" for nearly two decades. Mohanty's influential critique of western feminism (Chapter One: "Under Western Eyes") is also included in this volume, as with her latest ruminations about the ways that gender matters in the racial, class, and national formations of globalisation.

Grounded by the theoretical framework she has developed, her essays cover some of the most pressing and complex issues facing contemporary feminism: an analysis of the neo-capitalist exploitation by looking at the lives of women workers in the global assembly line; an

exposition on anti-racist pedagogies; a call for the reorientation of anticapitalist, transnational feminist solidarity practices; and a look at feminist writing on experience, identity, and community, among others.


Her provocative take on feminist concepts such as "home," "sisterhood," "experience" and "community" leads the women's movement journey toward a feminism without borders, a feminism fully engaged with the realities of a transnational world.



There is an underside (and a human side) to development, and feminism has made inroads into the highly technical debates and frothy prophecies by examining what the future really holds for the people. This book highlights the ways in which feminist analysis has contributed to a richer understanding of international development and globalisation, including the formation of global markets, economic restructuring, labour market informalisation, the feminisation of the labour force, and the changing patterns of gender constructions.

By combining theoretical, empirical and political perspectives, the book discusses the cutting-edge debates around development, globalisation, economic restructuring and feminist economics. Gender, Development and Globalization is an excellent primer on global feminist economics.

the ssessing strengths and weaknesses of a decade of women's participation in UN conferences, transnational networks, national advocacy efforts and sexual and reproductive health provisions, this book stands as an important contribution to current discourses on gender, health and human rights. It also presents case studies of national-level reform and advocacy efforts, and appraises the controversy concerning TRIPS, trade and essential AIDS drugs, which Petchesky considers as the "collision course of transnational corporate and global trade agendas with the struggle for gender, racial and regional equity and the human right to health."

Casting a feminist lens on key events and organisations influencing reproductive health and sexual rights struggles today, *Global Prescriptions* also provides a sober and insightful look into transnational women NGOs, arguing that the power of women's transnational coali-

tions is only as good as their organic connection with grassroots social movements. This is a highly recommended book from an author who has been consistently exploring the interfaces between political science, gender studies, health and human rights.

his volume docu ments powerful lessons in empowerment drawn from the varied experiences of four Asian NGOs engaged respectively in: (i) participatory approaches to rural development (Pakistan); (ii) solutions to the problems of violence against women (Malaysia); (iii) improved conditions for Tamil estate workers (Sri Lanka); and (iv) capacitybuilding for local and community-based organisations (India). Besides presenting a diverse range of approaches to people's development, the book also describes new trends among NGOs working with marginalised groups in Asia.


Narrated by people actively involved with the projects recounted, the contributions look at programmes of rural development, community organisation, women's empowerment and capacity building. The book addresses critical issues such as NGO concerns regarding specific programmes and target groups vis-à-vis the application of fundamental principles; ways where groups can advance within civil society; tools of empowerment; and the clear relationship between NGOs and the state

The book provides many insights and lessons for NGOs, bureaucrats and administrators dealing with social and rural development, those in multilateral and intergovernmental organisations and funding agencies, and students of development and voluntary action.

ivil Society has be come a major power in the world. The stunning defeat of the controversial and secretive Multilateral Agreement on Investments, the massive worldwide WTO protests, and the yearly meetings of the World Social Forum are testimony to its coming of age. With tens of millions of citizens and more than a trillion dollars involved in advancing its agenda, civil society now joins the State and the Market as the third key institution shaping globalisation. However, it cannot fully mobilise its resources and power because it lacks a clear understanding of its identity.

Shaping Globalization argues that global civil society is a cultural institution wielding cul-



tural power, and shows how, through the use of this distinct power, it can advance its agenda in the political and economic realms of society without compromising its identity. The book then outlines the strategic implications for civil society, both locally and globally, and explains that its key task is to inaugurate "threefolding:" the forging, where appropriate, of strategic partnerships between civil society, government, and business.

The threefolding approach to governance shows how all activities in societies emanate from three separate but interacting realms—culture, polity and economy.

According to Perlas, identity builds the values and moral fibre of society, polity strives towards democratic participation and the realisation of justice and equity in society, and the economy ensures that the physical needs of society are met. He emphasises that the task of good governance is to ensure that the activities in the three realms remain healthy for society as a whole.

Authentic tri-sector partnerships, he said, are essential to promoting new modes of national



development and consequently, a different, sustainable kind globalisation. Using the model of The Philippine Agenda 21, the book shows how civil society and progressive individuals and agencies in government and business are demonstrating the effectiveness of this new understanding to ensure that globalisation benefits the poor, societies and nature

Bringing together methodologies from political economy, anthropology and history, the 10 essays in the book provide gendered analyses of the political, cultural and economic life of







World Social Forum: Challenging Empires Edited by Jai Sen, Anita Anand, Arturo Escobar and Peter Waterman

ince it was first held in Porto Alegre, Brazil in 2001, the World Social Forum (WSF). desribed by Anand as "a transnational exchange among social movements, NGOs and their practices and knowledge of local, national or global social struggle," has been challenging the hegemony of the neoliberal capitalist paradigm of globalisation and calling for alternatives.

Challenging Empires both celebrates and interrogates the WSF, hoping to "comprehensively portray and analyse the richness and depth of the initiative." This anthology of essays consists of critiques from international thinkers from the South and the North such as Arundhati Roy, Nikhil Anand, Jeremy Brecher and Nawal el Saadawi. It includes discussions transnational feminism, global justice, and global and national struggles. The book was formally launched at the

The publication of the book aims to inform the public about the WSF and enable a process of engagement with the global civil action, referred to by some as the "anti-globalisation movement" or "global justice and solidarity movement" or as the "alternative globalisation." Another aim is to stimulate more critical engagement with and interrogation of the three dimensions: the form of the political and the political discussion (WSF's concept of 'open space'); the question of the renewal of imaginaries and utopias and how to give content to "Another

World is Possible!"; and questions of strategy (including proposals, types of political organising, etc).

The text includes a ba sic, easy-to-read introduction to the discourses, practices and technologies that have been grouped together under the term globalisation. It outlines the historical contexts of globalisation, and addresses the politics of naming central to the



narrative and development of globalisation.

Understanding Globalization examines issues such as technology and changes in the way people experience and understand time/space; the ways in which such changes have influenced capitalism; globalisation as ideology; globalisation as a form of colonialism; the relationship between global forces and state global sovereignty; (in)security and the actualities and possibilities of global governance; the media and the idea of a global 'public sphere'; and the emergence, throughout the world, of a coalition of forces opposed to differof ent aspects globalisation.

This book is useful for students taking communication media, cultural studies, sociology, politics and development courses.
